Have us delete any data we have about you beyond what I, A. Fields, needs for tax purposes.

Express any concern you have about our use of your data.

Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline. This can be done by contacting A. Fields Painting directly through our email or phone. I do not store any client information on the website. I do have information stored on my personal computer which is not to be shared.

I do not collect payments online. I deal only with cash and check. Future credit options could be available through "Square". To date, 11-26-2013, this is not a current option. Once it is, this will appear in this statement.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a secure environment.
